

## Tac Safe Membership Agreement

### DEFINED TERMS

In this agreement, “Tac Safe” refers to Tactical and Safety Consultants, LLC, a *limited-liability company* organized and existing under the laws of the State of Arizona. “I” and “member” refers to the person whose name, signature, and initials appear on this document. “Member” refers to the member named above whose financial institution is billed when a membership is in effect. Membership is limited to one (1) person in their individual capacity and **cannot** be transferred to another person.

### MONTHLY MEMBERSHIP \_\_\_\_\_ (member initials)

This agreement is **\$95.00 per month**, charged to the credit card or bank account monthly. It is a legally binding obligation for which I, the member, am financially responsible for the entire account, which automatically renews monthly until termination. I agree that if I fail to pay when a payment is due, I will be required to pay the entire unpaid balance immediately or at the time of next use. If collection or legal services are needed to collect the unpaid amount, I am responsible for all costs of collection, including attorney’s fees of Tac Safe. All claims, terms, and conditions for this agreement are associated with this Club Location.

### MEMBERSHIP ACCESS TO TRAINING \_\_\_\_\_ (member initials)

Members may attend up to **3** training classes per month, which are included in the membership at no additional charge. Tac Safe will schedule training classes based on member demand and instructor availability. Tac Safe projects to have at least **3** monthly training classes at various times. Members who wish to attend more than **3** training classes can do so and pay the going rate.

### MEMBERSHIP CANCELLATION \_\_\_\_\_ (member initials)

I understand I can cancel this agreement for any reason by providing **written notice** to Tac Safe by email two weeks **before** the auto-renewal date. The notice must say the members do not wish to be bound by this agreement. **Tac Safe may cancel this membership without refunds at any time, effective immediately, for any violation of safety protocols while using member benefits.** Unless you cancel this membership as set forth above, it automatically renews monthly. The member is obligated to pay monthly dues regardless of whether the member benefits are used or accessed. If the member cancels after the renewal date, Tac Safe is NOT required to refund any amount due to the late notice. **NO CASH REFUNDS** will be provided for any pre-paid fees.

### ASSUMPTION OF RISK OF INJURY \_\_\_\_\_ (member initials)

By signing this agreement, the member/you assume all risks of injury and waive all rights to pursue monetary damages or any other relief of any kind as a result of anything occurring, as a result of using or accessing the membership benefits or training at any location the member benefits are used. If you are injured while using your member benefits or during any sponsored event, I agree to hold Tac Safe **harmless** and all their owners, employees, agents, successors and assigns from all claims of any sort for damages or other relief, including claims for contribution. This liability waiver applies to my family members, successors, heirs, and assigns.

**WAIVER REGARDING LOCATIONS AND ACKNOWLEDGEMENT OF POTENTIAL MEMBER LIABILITY**

I understand and agree that the location of Tac Safe training opportunities and company events where I access my membership benefits can be essentially anywhere and may be unsupervised with no location employee on site to help me use the space in the manner that I choose to undertake the training opportunity afforded by Tac Safe.

I acknowledge there is a possible danger connected with membership activity. I knowingly and voluntarily waive my right to make a legal or equitable claim of any sort against Tac Safe and all of their owners, employees, agents, successors, and assigns from all claims of any sort for damages or for other relief, including but not limited to claims for contribution, arising out of or in any way related to my use of or decision making in the training opportunities afforded to me at various locations and with any equipment I request to use from Tac Safe. Moreover, I acknowledge that I am liable for all damage I caused to Tac Safe equipment or the physical infrastructure of the location. I will reimburse Tac Safe or the location via the payment method used to pay my monthly dues. I understand and agree that Tac Safe equipment and location are only available to me during the scheduled times and the membership benefits can be accessed.

I acknowledge that Tac Safe may request to process a federal background check on me to utilize membership benefits associated with certain firearms or ammunition uses, and I shall comply. Any personal information collected by Tac Safe shall be returned to me in its entirety unless federal law requires it to be on file; then, it will be securely stored for the time period required by the federal mandate triggering the storage requirement and will be securely destroyed after the mandated storage time period expires. No personal information will be used for any purpose other than for the purpose required by federal mandate and will not be disclosed to any 3<sup>rd</sup> party. Only the Tac Safe managers will have access. If you are a state resident of California, Maryland, Massachusetts, Virginia, or Washington, please disclose this to Tac Safe before collecting your personal information.
